

The school is directed to ensure that :

- The total number of sections of the school shall be restricted to 18 of which not more than 1/3rd sections may be used for senior secondary classes. Further increase of

sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law.

- 2 The school is required to submit the complete lease deed and sale deed (in r/o the owner of the name) within 03 months and submit compliance on SARAS.
- 3 The library is seen as under stocked. The school shall upgrade it as per SoP issued by the Board and submit compliance within 3 months on SARAS with the invoice and videography.
- 4 The school is required to replace the plastic chairs with the wooden stools in the science labs and install fire extinguishers in chemistry and composite science labs within 03 months and submit the compliance.
- 5 The school has overlaid a ramp on a stair case to access the upper floors which can be seen as too steep and unsafe to navigate and is not as per norms. the school shall dismantle it and construct a proper ramp as per norms of RPwD Act and guidelines issued by the Board or install a lift for CWSN to access the upper floors within 3 months and submit compliance on SARAS with videography.
- 6 The school shall develop the outdoor sports area as per SoP issued by the Board within 3 months and submit compliance on SARAS with videography.
- 7 Proper approach from the gate to the main building is not seen. the school shall make a paved/concrete approach pathway from the gate to the main building within 3 months and submit compliance on SARAS with videography/
- 8 The school shall conduct training of its teachers with CoE Prayagraj within 3 months and submit the compliance on SARAS with Videography.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII , as the case may be.

9. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.




